

RANGE RULES - WAIVER OF LIABILITY

Please read the rules and waiver and sign below signifying your willingness to abide by same.

1. No alcohol in or around the shooting area until all firearms are empty and secured for the day. **NO EXCEPTIONS.** A violation will mean disqualification and automatic removal from the range and the match.
2. No drugs are allowed anywhere on the range at any time. Drug use will mean disqualification and automatic removal from the range and match.
3. No gun handling behind the firing line unless you are in a designated safe zone or moving guns from your carts or storage areas.
4. No loaded weapons behind the firing line or in the spectator area at any time. Guns will be loaded and unloaded under supervision in designated areas only.
5. No guns will be discharged unless the shooter is under the supervision of a range officer at the firing line or other designated area.
6. Rifle and shotgun actions will remain open until they are loaded. Pistols will remain in holsters until shooter is on the firing line or in a designated safe zone.
7. Safety glasses must be worn at all times, on and behind the firing line, by shooters and spectators.
8. Hearing protection is recommended at all times, but must be worn while on the firing line.
9. Only approved weapons are allowed in the match.
10. All SASS rules apply to the conduct of this match and will be observed.

Waiver Statement

- I recognize the inherent dangers associated with shooting and have no intention of handling my weapons in a manner that may be unsafe to others. I understand this is a COLD RANGE and that my firearms must be unloaded at all times unless I am on the firing line and under the supervision of a Range Officer.
- I am aware of the loud noise associated with live fire and the ever present possibility of being struck by rebounding bullet fragments. I will always wear eye protection on and behind the firing line and will ensure that my guests do likewise. I will always wear ear protection while on the firing line.
- I shall fully indemnify and hold harmless the UP THE CREEK GANG and LAKE CHARLES GUN CLUB, it's Officers, the Range, the Range-Officers, and Club Members from all claims, causes of action, damages, losses, and expenses (including attorney's fees) of whatsoever nature, character, or description that any person or entity has or may have arising from or related to any incident resulting from any negligent act, omission, misconduct, or fault of the UP THE CREEK GANG and LAKE CHARLES GUN CLUB, it's Officers, the Range, the Range Officers, and Club Members.
